The City of Faribault licenses plumbers on a yearly basis beginning on January 31<sup>st</sup>. If you wish to be licensed for 2018 fill out the enclosed application and return it prior to January 31, 2018. **Please complete the entire form. The State of Minnesota requires cities to provide a Federal Employee Identification Number or Minnesota Business/Tax ID Number in reporting.**

**Include a copy of your 2018 bonding and insurance certificate, a copy of your 2018 license, along with the \$50.00 license fee when submitting the completed application.**

The current Residential standard charges for 2017-18 WAC/SAC are as follows:

WAC \$1030.00 per unit

SAC \$1500.00 per unit

**Please call for new amounts beginning March 2018.**

Also, Non-Residential WAC/SAC units may vary depending on the type of use. Check with the City of Faribault regarding WAC/SAC fees and units required.

Other fees include:

Residential Dwelling	\$ 99.00
Alteration or additional fixtures	\$ 66.00
Apartments/ per unit	\$ 66.00
Commercial/Industrial - base fee	\$155.00
Additional plumbing fixtures	\$ 5.00 each
Septic	\$375.00

**Above fees require an additional \$1.00 State surcharge.**
